

Message Summary

- a) This message looks at Psalms 2 and an end-time conspiracy led by an antichrist cabal comprised of the world's wealthy, powerful, and influential elite, who want to remove God and His Word from culture. This cabal is an antichrist movement that is preparing the way for two future antichrist kingdoms, known in Scripture as the 7th and 8th kingdoms.
- b) This message also discusses *The Great Reset*, which the global elite are presently attempting to establish in the Western world. This plan will fundamentally change the global economy from free-market capitalism to a hybrid of fascism and capitalism, what they call stakeholder capitalism.
- c) It's vital the church recognizes the prophetic hour of history in which we live. We are living in a transitional time in world history and many things about our lives could soon change. The pressure to compromise and even apostatize by compromising the Word or denying the name of Jesus Christ will increase substantially.
- d) As our eyes are opened to what is happening in the earth, it inspires us to resist the spirit of the age, get ready for the Lord, for eternity, and for the times in which we live, and to restrain the rising lawlessness through prayer and intercession.

My Burden for This Message

- a) Sometimes, when I am trying to determine what the Lord wants me to communicate in a message, I ask myself *what is my burden for this message?* This helps me narrow down the direction I need to go and helps me focus my words on what the Spirit wants me to say.
- b) What is my burden for this message? The 7th kingdom (an antichrist kingdom with regional dominion—primarily in Europe and the Middle East—but having global influence and impact) is rising up and very few believers know this or understand it. The 7th kingdom will eventually give rise to the antichrist and the 8th kingdom, which the Lord Jesus Christ will destroy at His second coming. So, one of my burdens is for the church to *recognize* the prophetic hour of history in which we live.
- c) Here's another burden I have. If the 7th kingdom is firmly established, many things about our lives will change and the pressure to compromise and even apostatize by compromising the Word or denying the name of Jesus Christ will increase substantially. So, another burden I have is for the church to *resist* the spirit of the age.
- d) The third burden I have is most of the church is not ready for what is coming. Looking at the signs of the times through God's prophetic lens, I'm convinced Jesus could return in my lifetime, perhaps in the next 10-20 years. And most of the church is not ready for Him or the challenges of living in the end times. So, my third burden is for the church to be *ready* for the Bridegroom's coming.
- e) My fourth burden is for us to *restrain* this antichrist movement through intercessory prayer. I say this from an American perspective—if you live in another country, you need to seek the Lord for His strategy for your nation. After a careful study of the prophetic scriptures and waiting on the Lord in prayer, I don't believe it's the Lord's will for the rising antichrist kingdom to take root in America. Though our nation is presently under the Lord's judgment, I still believe our prophetic destiny is to be a refuge nation from the antichrist kingdom rising up. So, my fourth burden is for the American church to *restrain* the spirit of antichrist from making America a major part of the 7th kingdom.
- f) For the sake of time, I will only talk about *recognizing* where we are at and where things are headed. In future messages, we will focus on *resisting*, *restraining*, and getting *ready*.
- g) As you listen to this message, keep in mind understanding fuels resisting, readiness, and restraining. As our eyes are opened to what is happening in the earth, it inspires us to resist the spirit of the age, get ready for the Lord, for eternity, and for the times in which we live, and to restrain the rising lawlessness

The Seventh Kingdom

- a) Before I summarize the 7th kingdom, let me state my philosophy about the end times. Namely, *it is more important to be ready than to be right*. Though I have taken great care to carefully research and study everything over many years, and to hopefully communicate this in a straightforward and simple way so that you can understand, I seriously doubt I have perfect understanding of the way everything will unfold. Understanding end-time prophecy can be complicated, so that is why I say it is more important to be ready than to be right (even though I do believe I am right, else I wouldn't be teaching it).
- b) To better understand where we are, we need to see where things are heading. I am referring specifically to the rising 7th kingdom. As I talk about this, keep in mind, when the elders spent time waiting on the Lord at the end of 2021 for what the Lord was saying as we entered 2022, the Lord spoke to dad and myself independently that the church needed to understand the 7th kingdom.
- c) Drawing from Revelation 17:9-11 and Daniel 2,7, there have been six antichrist kingdoms in history. These kingdoms have had regional dominion with international influence and impact. Each of these six kingdoms have persecuted the Lord's people. These kingdoms are: Egypt, Assyria, Babylon, Persia, Greece, and Rome. But Revelation 17:9-11 tells us there will be two future antichrist kingdoms—the 7th and 8th kingdoms—and the 7th kingdom will prepare the way for the antichrist's 8th kingdom.
- d) When teachers and authors describe the antichrist and his final empire, they often lump the 7th kingdom and 8th kingdom together. This usually results in confusion and misunderstanding. There are important distinctions between these final two kingdoms we need to understand. For the sake of time, I will only detail the characteristics of the 7th kingdom in this message. But there are links at the end of the notes with more information about the 7th and 8th kingdoms.
- e) *The 7th Kingdom* is what many scholars call the revived Roman empire. In my opinion, this kingdom began in its infancy in 1993, when the European Union (EU) was established. But I think the 7th kingdom will be far more expansive than the EU.
- f) If the 7th kingdom began in 1993, it has been on the rise for 29 years. Perhaps it will take 10-20 more years before it has the power and influence over much of the world as described in Revelation 17-18. But it certainly seems to be on the rise with The Great Reset and the UN's 2030 Agenda.
- a) The table below describes the 7th kingdom.

Characteristic	Explanation
Duration	A short time (perhaps 40-50 years?).
Dominion	The Lord will grant the 7 th kingdom dominion in much of Europe and parts of the Middle East, but it will have global influence and impact.
Beginning	Several few decades before Jesus returns. Likely began in its infancy in 1993 with the EU.
Characteristics	A guise of tolerance, peace, unity, compassion, equity, and justice, which will deceive and manipulate the nations, helping the elite to gain greater wealth, power, and control.
Established by	Uniting the nations through a prosperous economy, a tolerant religious system, and common legislation.

Characteristic	Explanation
Religion	Government-run church which merges together Islam, Christianity, and Judaism into a one-world religion. In all likelihood, it will also integrate other religions and even woke ideology, which promotes social justice and the LGBTQ agenda.
Government	Hybrid of socialism, fascism (corporatism), and technocracy.
Economy	Hybrid of socialism and capitalism, known as Inclusive Capitalism or Stakeholder Capitalism.
Elites' Goal	Gain extraordinary wealth, power, and control.
Satan's Goal	Intoxicate the nations, defile the bride of Christ and keep her from being made ready, and prepare the world to worship the antichrist.
Scripture	Revelation 17-18
Response	The nations will unite and align themselves with the one-world economy, one-world religion, and one-world government.

The Great Reset

- a) This global cabal, the elite who control much of the world's banks, governments, media, big tech, big pharma, and international corporations, are calling for *The Great Reset*.
- b) *The Great Reset* is being pioneered by the World Economic Forum (WEF) under the leadership of Klaus Schwab. This is part of the UN's 2030 Agenda, which is a blueprint for global government by the year 2030. The WEF is attempting to transform the global economy from free market capitalism/shareholder capitalism to what they call inclusive capitalism or stakeholder capitalism.
- c) I won't bore you with all the details, but this basically means a public-private partnership between government and big corporations and banks to control the world's population through money. The elite will become extraordinarily wealthy while the majority of the world will become like serfs.
- d) Basically, this global cabal wants to control everything in the world—money, education, healthcare, religion, culture, justice, equity, natural resources, industry, infrastructure, media, cities and communities, consumption, and production—anything and everything you can fathom. They want total control over everything, including what we are allowed to believe about God and the Bible.
- e) The WEF states *you'll own nothing. And you'll be happy*. Instead of purchasing, *whatever you want you'll rent and it'll be delivered by drone*. The WEF has also predicted *the US won't be the world's leading superpower* because they foresee a future where *a handful of countries will dominate*. And finally, if you are a meat lover, the WEF boldly declares *you'll eat much less meat. An occasional treat, not a staple for the good of the environment and our health*.
- f) Their plan for global government is not communism, socialism, or Marxism, though it contains some elements of each. It's more like global fascism—an international partnership between government and big corporations. Instead of making a nation great, such as *Make America Great Again*, they want to make world government great.

- g) The WEF plans to enforce control over much of the world through what is called an ESG credit score. E stands for Environmental, S stands for Social (Social Justice), and G stands for Governance. Presently, if you want to get a mortgage or a car loan, the lender looks at our credit score to make sure we can pay back our loan. Under the ESG credit score, however, the flow of money will be controlled by how well we comply with the government's philosophies, whether we adhere to their standards for climate control, social justice, and equity.
- h) What concerns me the most is the S part of the credit score—the Social Justice part. This will directly affect Christians who hold to a biblical worldview. It will basically mean you will have to align with government's woke ideology or you will be punished, even financially excluded. This will likely mean if you go to a church that preaches biblical sexuality—that sex is only permissible in the covenant of marriage between one man and one woman—then the S part of your score would be greatly affected. If you are a pastor, like me, and you preach biblical sexuality, then this means I may not be able to get loans, my social security, or my IRA, etc. And if you go to a church who preaches biblical sexuality, your ESG score will be diminished, possibly affecting your ability to get a house, car, etc.
- i) Have you ever wondered why almost every company has gone woke, promoting the LGBTQ agenda and social justice issues? It seems like overnight, every company in America started pushing woke ideology. Have you ever stopped to wonder why? Is this just a random cultural phenomenon? No. Most business don't care about these things; all they care about is making money. The reason for pushing all the woke ideology is because the banks and the investment firms, who are pioneering The Great Reset in partnership with the WEF, are letting corporations know that they must have a good S part of their social credit core to receive investments and loans.
- j) To really understand all that happened from 2020 to 2022—including government shutdowns, printing exorbitant amounts of money, race riots, mandates, media propaganda, misinformation about Covid, etc.—you have to understand *The Great Reset*. To me, it feels like Nazi Germany in the 1930s as Hitler was rising to power, except this time, it isn't limited to one nation, but to the entire Western world, including America, Canada, Australia, and Europe.

The Great Reset in Canada

- a) To see how the WEF's Great Reset will fundamentally change democratic nation states into a fascistic global government, look at Canada.
- b) Justin Trudeau, the Prime Minister, and Chrystia Freeland, the Deputy Prime Minister, were both groomed by the WEF's Young Global Leaders Program. Trudeau has also openly praised China, whom many globalists see as the perfect model for global government. Over the past 50 years, many globalists believe the CCP has now found the right balance between communism and capitalism and they view China as the model for world government.
- c) In case you don't know what is taking place in Canada, here's a quick summary. The Canadian government required truckers to get the vaccine. Many truckers revolted against this vaccine mandate and demonstrated with a peaceful protest in Ottawa. All they are asking for is the Canadian government to drop the vaccine mandate.
- d) In response, the Canadian government has labeled these peaceful protesters, who just want the freedom to choose what they put into their bodies, as white supremacist terrorists. The government has enacted the Emergencies Act and frozen the bank accounts and crowdfunding sources for these truckers.
- e) The Canadian government has now sent the police into these peaceful protests, attempting to end it, even arresting those who are leading the trucker convoy.
- f) In essence, the Canadian government, aligned with the WEF, has basically morphed into a globalist dictatorship overnight.

- g) This is an up-close and personal example of how the WEF's Great Reset seeks to fundamentally transform the Western world. The government tyranny you see taking place in Canada is what the global elite want for the entire Western world, including America, Australia, and Europe.
- h) For the sake of time, I won't discuss any more about *The Great Reset* in this message. But I strongly encourage you to learn about this. This movement has made significant headway in many Western nations, including America. This has the potential to radically transform everything about your life. If you want to learn more about *The Great Reset*, I have some additional resources at the end of these notes.

Terry Bennett's 21-Year Prophecy

- a) If you are familiar with Terry Bennett's 21-year prophecy, which he received in 2001, you know 2022 begins the third cycle of seven years. To help those unfamiliar with this prophecy, I will give a quick review.
- b) Before I start, I want to say how stunningly accurate this 21-year prophecy has been. As Scripture commands us, we are not to despise prophecy but should test everything carefully and hold fast to what is good.
- c) *2008* – This began the first series of 7 years and was related to economic shaking. This was definitely fulfilled with the financial crisis of 2008—the most serious economic crisis since the Great Depression. Terry was told this shaking would lead to the economic part of the antichrist kingdom. I think you can look at The Great Reset and see what could possibly be the fulfillment of this part of the prophecy.
- d) *2015* – This began the second series of 7 years and was related to government shaking. With the election of Donald Trump in 2016, his presidency from 2017-2021, and the exposure of what many call the Deep State, the government, especially in America, has been shaken, just as was prophesied. Not to mention the ripple effects of the globalist agenda in many other countries around the world. I honestly don't know whether America is still a Constitutional Republic. Terry was told this shaking would lead to the government part of the antichrist kingdom. I think you can look at the UN's 2030 Agenda and their 17 Goals of Sustainability and see what could possibly be the fulfillment of this part of the prophecy.
- e) *2022* – Terry was told 2022 would be the year when the elite would merge together Christianity, Judaism, and Islam into a one-world religion. It's interesting that the Abrahamic Family House, a worship center with a mosque, church, and synagogue, is slated to open in Abu Dhabi in the UAE in 2022. This project has been spearheaded by Pope Francis, a strong proponent of a one-world religion.
- f) *2029* – Terry was told the three core components of the antichrist kingdom would be established—the economic, governmental, and religious. This corresponds perfectly with the UN's 2030 Agenda, the blueprint for global government the elite want in place by 2030.

An Integrated Religion, Economy, and Government

- a) In Terry's 2001 prophetic encounter, Terry was told *through chaos they will gain control*. This is the key cog in the elite's playbook. They manufacture a crisis and then provide a solution to the crisis they created, gaining greater control in the process.
- b) Now that Covid-hysteria is dying down and the global elite can't control nations with fear of a virus, they need some other type of chaos or common enemy to gain control over the nations. One thing they are pushing hard is climate change. They are trying to scare the masses that our world will be destroyed in 10 years if we all don't act together to solve this crisis. This corresponds to the E part of the ESG social credit score being pushed by the Great Reset.
- c) In addition to climate change, the elite will use a one-world religion to gain greater control and increase their wealth. Soon, they will begin to promote some type of one-world religion that merges together Christianity, Islam, and Judaism, quite possibly other world religions. This one-world religion will likely

include many of the popular social justice issues of wokeism, including the LGBTQ agenda. This corresponds to the S part of the ESG social credit score.

- d) In Revelation 18:23, when John saw the great harlot that promotes false religion to the nations, notice carefully that her “merchants were the great men of the earth, because all the nations were deceived by [her] sorcery” (Rev. 18:23, emphasis mine). These great men, these international merchants, likely include the world’s leading CEOs, bankers, investors, business people, technology leaders, and pharmaceutical leaders.
- e) Here’s a very plausible scenario of how the coming harlot religion will be integrated into the global economy and global government. The elite will use the harlot religion to enforce the S part of the ESG social credit system. If you don’t comply with their definition of sexuality or if you preach that Jesus Christ is the only way to God, for example, you could be deemed unsafe for society, a potential terrorist and an intolerant bigot. As a result, your ESG credit score would go down, you would be flagged as a threat to society, and you would be excluded from receiving loans, your retirement, and social security. You could even be labeled a terrorist and have your bank accounts frozen.
- f) The elite will use the harlot religion to increase their control, power, and wealth while Satan will use it to intoxicate the nations and prepare them to worship the antichrist.
- g) The economic pressure coming to Christians will not be easy. We will be tested based upon whether or not we compromise with woke ideology, the LGBTQ agenda, and universalism.
- h) In Revelation 2:18-29, the church of Thyatira faced a similar challenge to what many of us will face in the end times. In Thyatira, there were trade guilds that the community had to participate in for them to succeed in business and to prosper. At these trade guild meetings, a patron god was worshiped and there were acts of immorality. It was a real challenge for the believers at Thyatira, who had to make a choice between business opportunities in exchange for compromise or purity which would cost them prosperity and affluence.
- i) A similar test could be coming to believers in the Western world through *The Great Reset*. That is why we must resolve not to compromise.

God Laughs at Their Plans

- a) I want us to end on a good note. Remember what we saw a few weeks ago, when David prophesied, “He who sits in the heavens laughs, the Lord scoffs at them. Then He will speak to them in His anger and terrify them in His fury” (Ps. 2:4-5).
- b) No matter what happens, the Lord is in absolute control. In His sovereign power, the Lord laughs with derision at the cabal’s conspiracy. These arrogant, wicked men and women, operating under a spirit of antichrist, will stir up the wrath of the Lamb. When He arises to shake the earth, these wealthy elite will be fleeing to the caves, attempting to hide themselves from the Lamb’s wrath (Rev. 6:12-17).
- c) Don’t allow fear or a defeatist attitude to lodge in your heart. The Lord laughs at their plans because He is in absolute control, and therefore, we must put our trust in Him. He must become the stability of our times (Isa. 33:6).
- d) We should not fear the plans of the antichrist cabal, the antichrist, the devil, or whatever may happen in the world.
- e) Isaiah 8:13 states we should only fear God and be in dread of Him. Not anyone or anything else.
- a) Since the Lord sits in the heavens and laughs at the plans of this evil, antichrist cabal and because God is good, He will take whatever happens and will work out for our good and His glory.

- f) The Lord alone is the stability of our times (Isa. 33:6). He is unshakeable and therefore we should rest in Him, trust in Him, and be confident in His ability to move the chess pieces to victory.
